## Additional comments, 2;

These are additional comments made on the forms, but with agree or strongly agree for Q4 & Q5;

Unknown parent Q4 agreed Q5 strongly agreed and read behaviour policy but wrote – my concern is that bad behaviour/bullying frequents the school playground and sometimes misbehaviour can go unnoticed because of the volume of children on the playground. Not sure how to overcome this but as mentioned it is a concern. Sometimes children can be provoked and on occasions, this child who is having a difficult time, can retaliate and then the ones to get in trouble. It is important I believe for <u>all</u> children concerned to be asked about how the situation arose as there are always two side to every story.

This KS1 parent, name on form, agreed to Q4 & Q5 and wrote, maybe creative ideas to deal with bullying or unacceptable behaviour. i.e. gardening or community service, or giving up playtime to help a teacher. I do appreciate it has to be within rules and regulations.

Unknown key stage, name of parent on form, agreed to Q4 & Q5, but wrote we would like to see more escalation of when names go on the board more than once.
